1 Introduction

PrintTalk is an XML standard that provides a single format for printers to collaboratively communicate business transactions and print specifications with their buyers and among themselves. Print industry professionals from eCommerce companies, print Business Management Systems, printers, and print equipment manufactures contributed to the design of PrintTalk.

The PrintTalk standard embraces use of the Job Definition Format (JDF) and Commerce eXtensible Markup Language (cXML). The group's work has been recognized as an implementation of the JDF standard, and its work is embedded within the 1.1 release of JDF. By incorporating PrintTalk, the JDF intent list has been enhanced to provide a richer descriptive capability. While JDF describes the piece to be printed, PrintTalk specifies the external communication of business processes between printer and buyer. For details about JDF, see www.cip4.org.

The PrintTalk interface specification is distributed free of any license fees or royalties, in order to address the need for end-to-end connectivity in the printing industry.

The following pages describe the philosophy used to develop the specification and the business objects that make up PrintTalk: *Request for Quote, Quote, Purchase Order, Order Confirmation, Cancellation, and Refusal* constitute the initial PrintTalk release. Detailed examples and discussions of the other remaining business objects (*Order, Status Request, Order Status Response, Proof Approval Request, Proof Approval Response, and Invoice*) will follow in subsequent releases.

1.1 Intended Audience

While most print industry professionals will find sections of this specification interesting; our primary goal is to describe the PrintTalk protocol to programmers who wish to implement the PrintTalk interface specification within their software products. A working knowledge of XML and familiarity with JDF is required to fully understand the scope of implementing.

2 Business Objects

The following table lists the business objects supported by PrintTalk. Each object corresponds to a business transaction used in the commercial print industry. The list will expand as the PrintTalk specification grows to support other transactions and new industry areas. The first column lists the business transaction name, the second its description and use, the third defines the object which this object can refer to. "None" means that the object can be originated without responding to any other object. The fourth column describes the relative flow from Buyer to Printer. In some cases, the transaction will be used bi-directionally.

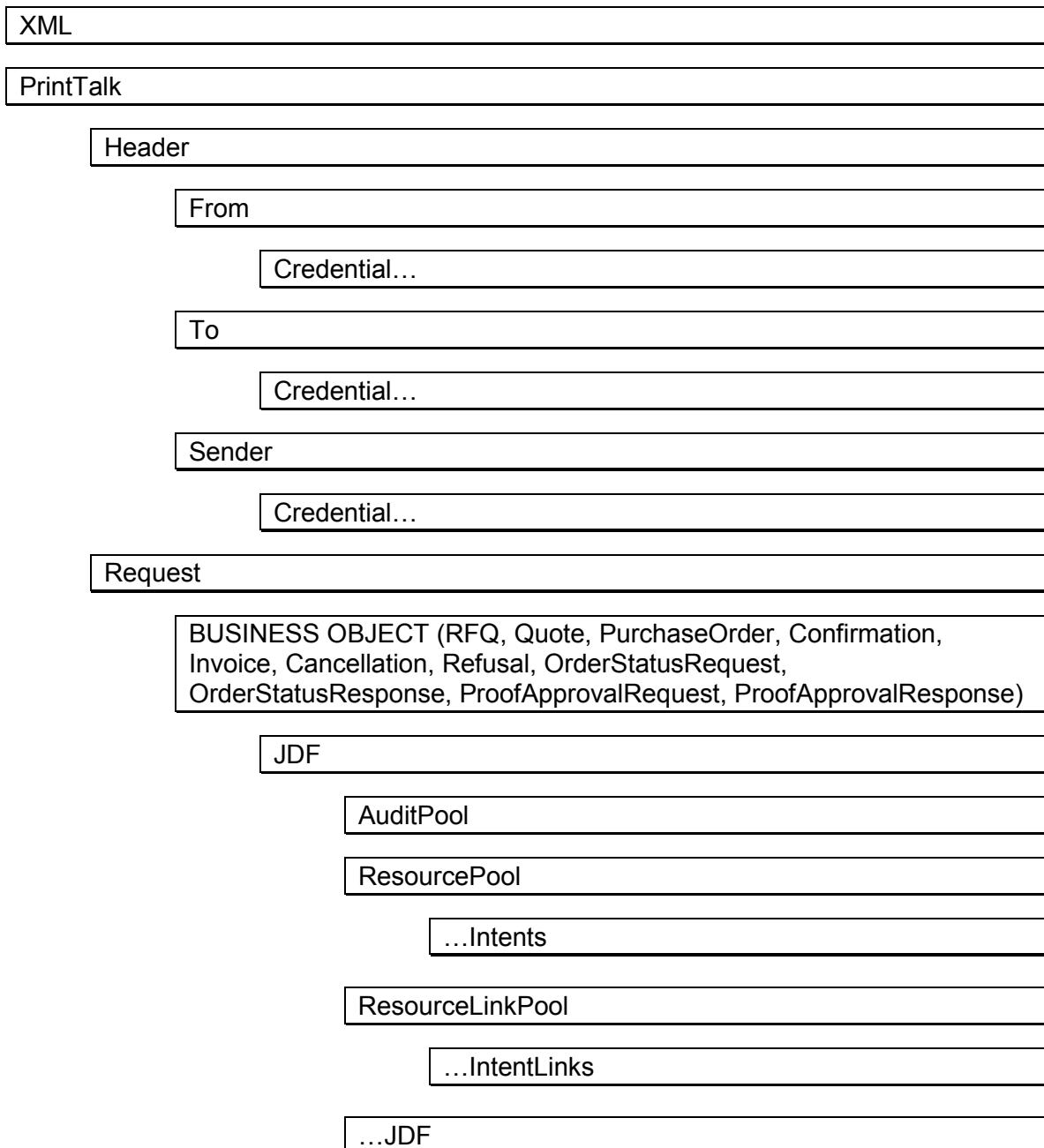
Business Transaction	Description	References	Flow
1. Request for Quote (RFQ)	Initiated by a buyer to a print supplier. It may instigate a new product process or it may supersede an existing RFQ. The focus of a RFQ is to convey the intention of the buyer clearly, in an unambiguous way to the print supplier. A complex RFQ may contain options that specify several types of acceptable materials or methods required by the buyer. It may contain other options that require the print estimator to generate more than one quoted price in the response. The Change Order and Request for Re-quote variations are included within Request for Quote.	None, Quote, Confirmation	B→P
2. Quote	Normally sent in response to a RFQ. The quote may contain very detailed information about the printing processes intended to create the product defined by the RFQ or it may contain only basic price and billing information. As with traditional quotes, providing the buyer with detailed information lessens the chance of a misunderstanding. The Re-quote and Change Order Quote variations are included within Quote. A Quote may supersede an existing Quote before the Print Buyer has answered with a RFQ or an Order.	RFQ, PO, Confirmation	B←P
3. Purchase Order	Typically sent as a response to a quote, but may be the initial document in a well-defined buyer / print supplier relationship or when ordering finished goods items. The Change Order variation is included within Purchase Order. An order may supersede an existing Order prior to the Print Provider	None, Quote, Confirmation	B→P

4. Order Confirmation	Sent by the print supplier to the buyer acknowledging receipt of the purchase order. It may contain information about expected due dates and final pricing that were undetermined at the time of the quote.	PO	B←P
5. Cancellation	Cancels a complete job. If only parts of a job should be cancelled, one must send a new RFQ, Quote, or PO. In case of canceling parts of a confirmed order the Change Order variations of these Business Objects must be sent.	RFQ, Quote, PO, Confirmation	B↔P
6. Refusal	Used to explicitly decline a Business Object sent by the counter party. Alternatively, the non-accepted Business Object expires.	RFQ, Quote, PO	B↔P
7. Order Status Request	Generated anytime one party requests status from another party.	Confirmation	B↔P
8. Order Status Response	An <i>Order Status Response</i> can be sent as a response to an <i>Order Status Request</i> or it can be sent automatically.	Confirmation, Order Status Request	B↔P
9. Proof Approval Request	Provides a transport for soft proofing from supplier to buyer. This may contain MIME data or a URL where the proof is located.	Confirmation	B←P
10. Proof Approval Response	Contains buyer's approval or denial of a proof.	Proof Approval Request	B→P
11. Invoice	Typically sent once the job is shipped, but can also be sent several times, when certain milestones during production are reached. May include additional charges or discounts.	Confirmation, Cancellation	B←P

3 Format Structure

The format most of the PrintTalk implementation can simply be described as JDF with a cXML wrapper around it (and a little PrintTalk in between). Just like cXML, the top two nodes are Header and Request. The Header concept is taken directly from cXML. The Header identifies the parties involved in this correspondence. The Request node contains one (and only one) Business object.

The following pages will provide a detailed explanation of each node. Here's a high level view of the PrintTalk structure:

This is an example of a Header taken from a Quote. In this example, the “To” party is a print buying company called PeterPan. The DUNS number uniquely identifies them. The “From” party is a print supplier. They too, are uniquely

identified by a DUNS number. The **Sender** is the party sending this document. In this case it's an eCommerce company. The **SharedSecret** element is a password known to (at least) the eCommerce company and the "To" party.

The content and exact format of this section will depend on the specific implementation. All parties should agree to the format prior to sending messages.

From

To

Sender

From cXML: The **From**, **To**, and **Sender** elements allow receiving systems to identify and authorize parties. The From and To elements in a document do not change. However, as the document travels to its destination, intermediate nodes (such as Ariba Network) may change the Sender element.

For example, in an RFQ, the *From* party is the buyer. The *To* party is the print supplier. In the subsequent Quote, those roles reverse. The *Sender* is always the party sending the message.

Credential

Credentials identify and authenticate the various parties involved in this transaction. Credentials are required in all 3 sections (From, To, Sender).

The entire Header section is taken directly from cXML. Refer to the *cXML Users Guide* available at www.cXML.org for more information.

3.2 PrintTalk Request Details

Request

The name “Request” is another element taken from cXML. A Request, in the case of PrintTalk, contains one (and only one) business object.

3.2.1 Abstract Business Object

In PrintTalk 1.1 we have created an abstract node called *BusinessObject* from which all other business objects inherit and optionally extend. Elements in the abstract *BusinessObject* are present in all business objects (RFQ, Quote, PurchaseOrder...)

The following table describes the contents of the abstract *BusinessObject* element. For a detailed description of the used data types see the JDF specification.

<i>Contents of the abstract BusinessObject element</i>

<i>AgentID</i>	NMTOKEN	The unique identity of the user that “pushed the button” to send this document. Could be a buyer in an RFQ or an Estimator in a Quote.

Each individual Business Object within PrintTalk inherits all of the attributes and elements of the abstract *BusinessObject*. Additionally, each of these extends the abstract for individual items unique to that Business Object. The following sections show each Business Object and the additional elements specific to it.

3.2.2 RFQ

<i>ReplaceID?</i>	NMTOKEN	Identifier (BusinessID) of the document (if any) for which this document supersedes. A document can only supersede a previous one of the same type, i.e. a Quote can only supersede Quotes. Additionally, superseding is only allowed as long as the Quote to be replaced is pending, i.e. that the counter party has not yet answered.

JDF	element	Description of the print product. The JDF element can be used to very detailed specify a to be printed product, but it can also be used to describe the ordering of finished goods in catalog-based environments.

3.2.6 Confirmation, Cancellation, Refusal

These and the following business objects do not contain a JDF element. Consequently, they contain the JDF Contact element (see JDF specification for more details of this element).

There can be more than one JDF in a business object, but they will be nested below this JDF. Consequently, this JDF is referred to as the “JDF root node”. This node contains header information that a subsequent, lower JDF node would not contain.

PrintTalk does not require the AuditPool section. This section is intended to provide information regarding the product or author generating this document.

NOTE: Items defined in the following sections are all covered extensively in the JDF 1.1 release available at <http://www.cip4.org>. For the purposes of PrintTalk, we will provide some general assumptions and rules that may help to clarify the PrintTalk implementation of JDF.

ResourcePool

According to JDF, the ResourcePool is basically the list of resources required to produce a certain item. For PrintTalk's purpose, the ResourcePool of the top-level JDF node should contain, besides the resources that make up the customer information, only the DeliveryIntent that describes how, when and where the desired product should be delivered to. If the specification of the product contains options, several DeliveryIntents may be specified with each describing one option. In the ResourcePool of the subsequent JDF node the desired product is contained as component as well as the corresponding intents specified by the buyer in the RFQ, and then later refined by the printer in the Quote and Order Confirmation. This ResourcePool may also contain components from subordinate JDF levels and other resources. A notably exception is the ordering of finished goods. These are described by components and have no Intents associated with them. Therefore these components need not be described in separate JDF nodes and can be added to the ResourcePool of the upper-most JDF node (see e.g. example C in the appendix).

See the JDF 1.1 documentation for more information on ResourcePool.

...Intent

The resources in the ResourcePool are defined using a series of intent elements. These elements are the basic actions and/or materials required to build an item.

The complete list of intents used by PrintTalk and JDF:

The ResourceLinkPool defines the relationship from one resource to another and the usage of each resource defined in the relative ResourcePool.

In this example, the ResourcePool consists of one Component element that describes the output product for this JDF node and a FoldingIntent. The ResourceLinkPool has three items. In addition to a link to the resources of the ResourcePool there is a link to a component (**Item01flat**) that appears in the ResourcePool of a deeper JDF node. The implication in the ResourceLinkPool is that **Item01flat** is folded (**Fold1**) and the output is **Item01**. **Item01flat** and **Fold1** are both defined as *Usage="input"* because they are the resources consumed or used in this step. **Item01** is defined as *Usage="output"* because it is the resource created in this step.

CustomerInfo

The CustomerInfo is a container for customer-specific information like CustomerID, as well as contact information such as contact persons and addresses. This element usually is specified in the uppermost JDF node. For more information see the JDF specification.

4 PrintTalk Workflow

The workflow concept and presumptions are described in text below, with a detailed flow diagram on the following page showing the possible workflows using PrintTalk Business Objects. The diagram covers both the negotiation phase and the production phase and all possible loops that might occur.

RFQ

Usually the overall transaction starts with an RFQ. After the Print Buyer has sent the RFQ and while it is pending (i.e. the Print Provider has not yet answered on it), he or she can either cancel or supersede it. In case of a cancellation, the Print Buyer can either choose to stop the whole process or to continue by sending (later) a new RFQ or a PO (e.g. if there is already a Quote sent by the Print Provider that has not yet expired, i.e. the cancelled RFQ was in fact a Request for Re-Quote). If the Print Buyer supersedes the RFQ, he or she does so by just sending a new RFQ that replaces the pending one.

When a Print Provider has received an RFQ, he or she reviews it and either accepts or refuses it. A refusal may take place either in an active manner by sending a negative answer to the Print Buyer or passively by not answering and letting the RFQ expire.

Quote

If the Print Provider wants to accept the RFQ, he or she creates a Quote and sends it back to the Print Buyer. After the Print Provider has sent the Quote, he or she can similarly to the Print Buyer either cancel or supersede the Quote while it is pending. If the Quote has been cancelled and the process should go on, the Print Provider can send either a new Quote or a Confirmation, if there is a PO and the cancelled Quote was in fact a Re-Quote.

When a Print Buyer receives a Quote he also can either accept or refuse it. If he or she does not accept the Quote as it is, he or she can create a new RFQ called Request for Re-Quote. If the Print Buyer does not want to continue the negotiation, he or she can proactively send a refusal or do nothing and let the Quote expire.

PO

In case of accepting the Quote, the Print Buyer creates and sends a Purchase Order (PO). However a PO can also be the first object in a negotiation phase, especially if it is a Re-Order of a previously produced print product. Again, this business object can be cancelled or superseded once it is sent and while it is pending. If the PO has been cancelled and the process should continue, the Print Buyer can either send a new PO or he or she can send another RFQ to ask for a new Quote.

When a Print Provider has received the PO, he can either accept or refuse it. If he or she refuses it, he or she can send back another Quote called Re-Quote to let the process continue or he or she can stop the process by sending a refusal or letting the PO expire (although, the latter is not a very good business practice). However, if the PO does not alter from the Quote there are legal issues that prevent the Print Provider from refusing the PO.

If the Print Provider accepts the PO, he sends back a confirmation notice and the contract is finally established.

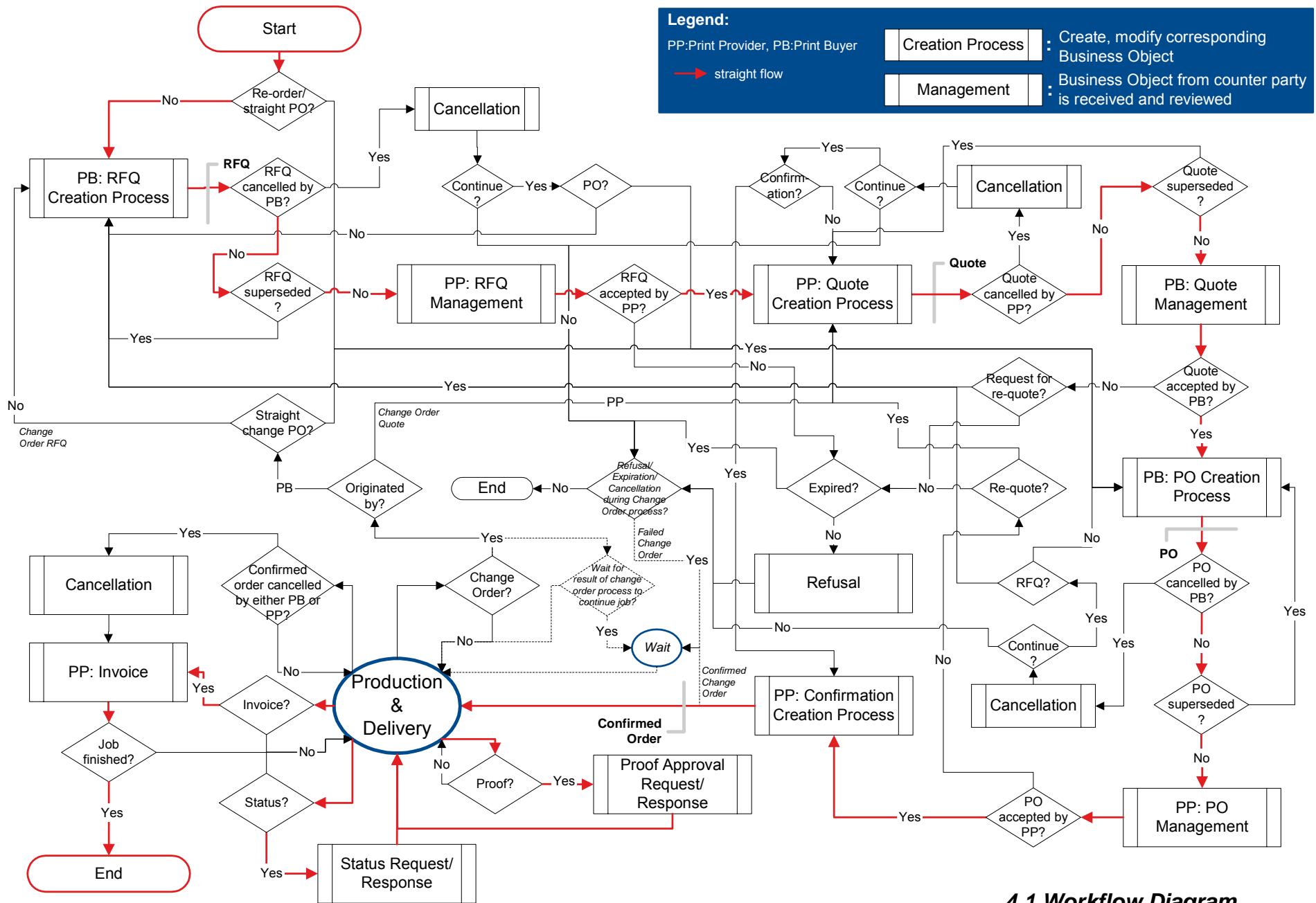
Change Order Process

Both parties can initiate a change order process. Either the Print Buyer sends a Change Order (CO) RFQ asking what the consequences would be for a certain change of the print product or he or she sends a straight Change Purchase Order (CPO). The Print Supplier may begin the change order process by sending a CO Quote, where he or she offers a possible or necessary change of the product.

The negotiation of the change order is performed by the same business objects as described above – RFQ, Quote, PO, Confirmation, Cancellation, and Refusal. The contract, which both parties have agreed on before, is valid during the whole change order process. However the production of the print product may be halted. Only if there is a new agreement on a changed order (expressed by the new confirmation that the Print Provider sends), the old contract is replaced. If there is a refused, expired, or cancelled business object that terminates the change order process, the process has failed and production goes on as originally planned.

Production and Delivery

During the production phase interaction between both parties takes place not only by change order processes but also by sending Status and/or Proof Approval Requests/Responses. Invoices are sent from the Print Provider to the Print Buyer either after delivery of the product or at various milestones. Moreover both parties can cancel the whole process in the production phase, which generally leads to a final invoice due to the Print Provider's terms and conditions.

Example B – “Bible”

In this example, we are producing two Bibles, one with a soft cover and another with a hard case cover and dust jacket. Just to make things interesting, the text is shared by both versions of books. We are producing 5,000 soft cover versions and 7,500 hard case versions. All are shipping to the same address.

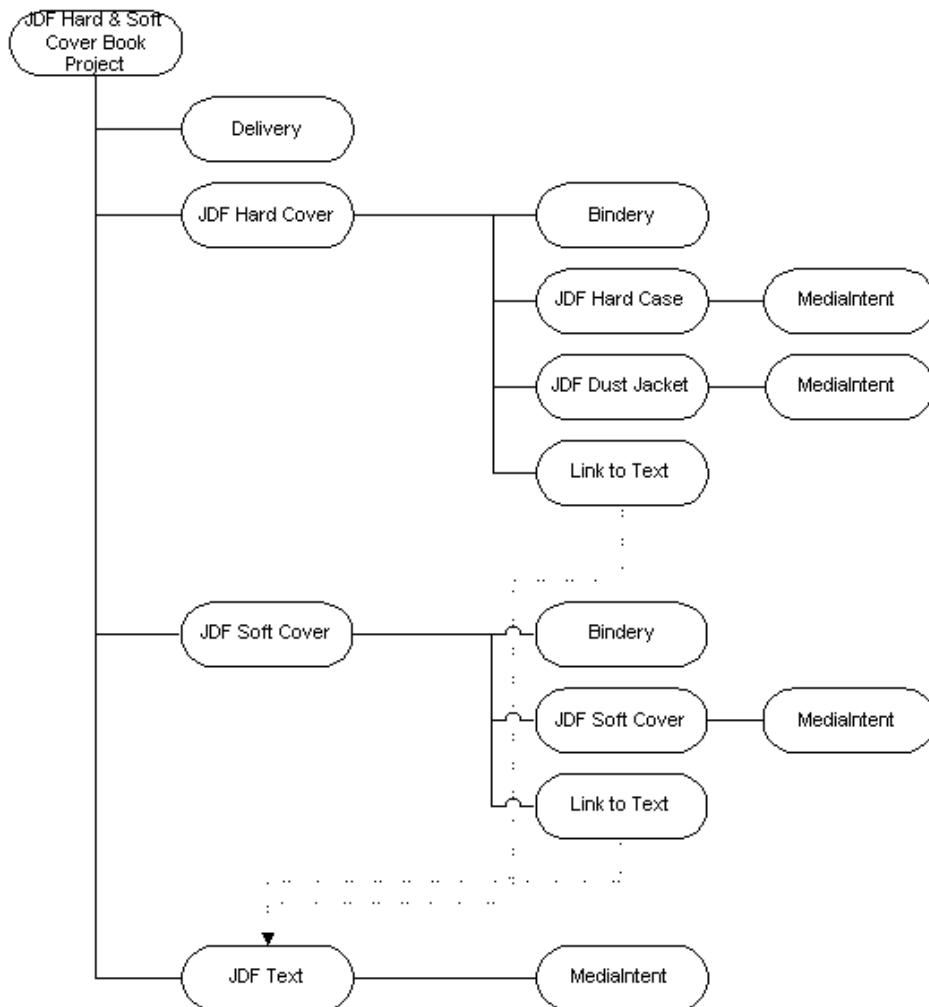

The root JDF level of this project combines the 2 finished products (soft and hard cover book), with the delivery intent. The second tier JDF specifications show the individual intents to produce each book. The specification for the text could be part of the specification on each of the books separately. Because it's a shared component, it is promoted to a higher level and can be referred (and consumed) by each of the lower JDF components.

Example C – “Sunrise PurchaseOrder”

In PrintTalk, the Quote response to an RFQ will look similar to that RFQ, usually restating many of the items in the original RFQ. In the same way, a Purchase Order response to a Quote will look similar to the Quote. Of course, in the PO, any *options* should be eliminated and the pricing should specify the exact quantity and tolerance for each delivery. It is also acceptable for the PO to simply acknowledge the quote and respond with acceptance without restating any of the specifications.

By using JDF, PrintTalk can support another kind of PO entirely. Sometimes, it's necessary to purchase an item from a printer that has a pre-established price and well-defined content. To embrace this Catalog-based part of the print market, JDF/PrintTalk allows finished goods to be ordered in a PO as components using the *CatalogID* and *CatalogDetails* attributes.

The following example uses Catalog elements as the contents of a Purchase Order.

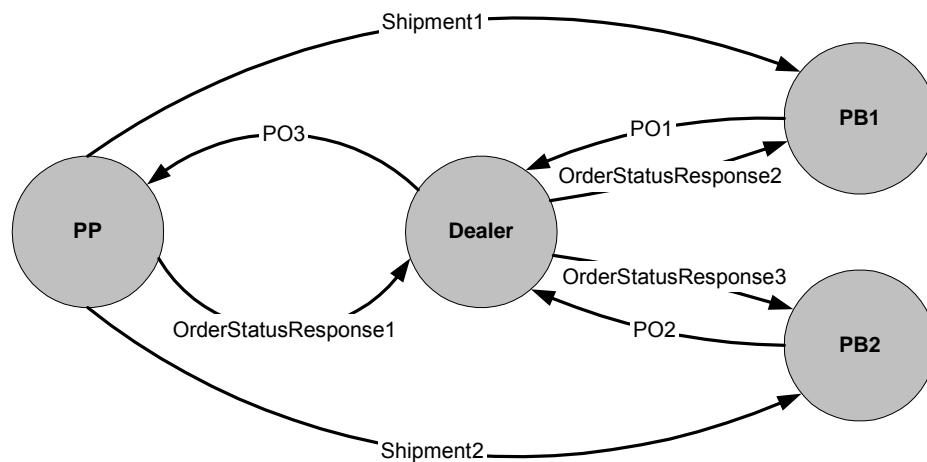

Example D – Collaboration scenario

In this section a possible scenario should be exemplified as it might occur between several parties involved in a print production process. It is assumed that the following four parties exist: A Print Buyer PB1 and a Print Buyer PB2 both are ordering products via a “dealer” which in turns forwards the orders to a Print Provider.

In a first step both Print Buyers send a Purchase Order to the dealer. The dealer then merges the two POs to a new one (PO3) and sends it to the Print Provider. The Print Provider finally sends status information back to the dealer who in turn might forward that back to his customers. On the other hand the physical products are sent directly from the Print Provider to the customers of the dealer including the end customer’s PO numbers.
